CITY OF SARATOGA SPRINGS, UTAH 2025 Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) Notice

In accordance with UCA § 20A-16-502, notice is hereby given that the 2025 Municipal Election for the City of Saratoga Springs, Utah, will be held on November 4, 2025 to elect the following offices to serve a four-year term each, from January 2026 to January 2030:

- ❖ Mayor
- ❖ City Council (2 positions)

Candidacy Filing Period:

June 2, 2025 through June 6, 2025, Monday – Friday, business hours 8:00 a.m. to 5:00 p.m. at the City Recorder's office, 1307 N. Commerce Drive, Suite 100, Saratoga Springs, Utah 84045.

2025 MUNICIPAL PRIMARY ELECTION **August 12, 2025** (if required)
2025 MUNICIPAL GENERAL ELECTION **November 4, 2025**

The Uniformed Overseas Citizen Absentee Voting Act is commonly referred to as *UOCAVA*. Those eligible to vote absentee under UOCAVA in Utah County elections are:

- Members of the United States Uniformed Services and Merchant Marine;
- Their family members; and
- United States citizens residing outside the United States, who maintain legal residency in Utah County.

To request a mail or email ballot through the [Federal Voting Assistance Program](#) (FVAP), fill out a Federal Post Card Application (FPCA) and mail, email, or bring it into the Utah County Elections office.

Electronic and Mailed ballots must be received by the Elections Office by 8:00 PM (Mountain Standard Time) on Election Day, Tuesday, November 4, 2025. For more information on the use of the
